The Chowerup Bush Fire Brigade would like to move a motion to expedite the burning of former Waters and Rivers Bush especially Lot 13 Location 8553 (670 hectares) and Lot 6 location 8553. Lots 10 and 12, 8553 either side of lot 13 will be planted with pines next year (2023) and the bush should also be burnt before the pines are planted. The bush was last burnt in 2006. Lot 6, 8553 (64 hectares) north of lot 12 should be burnt before pines are planted. This area was last burnt in 1987. Lots 10 and 11 are owned by New Forest and managed by P F Olsen.

If necessary delay pine plantings until bush is burnt.

5. Business arising

The question of firefighting facilities based at Wilga was again discussed.
 It appears unlikely unless there is future financial support from businesses
 / government bodies. Forrest Products Commission (FPC) have recently
 purchased the "Affleck" property with the intention of planting pine trees.
 As this property is directly adjacent to the Wilga town site, it may be worth
 approaching FPC in the future to seek support for the provision of these
 facilities.

- The number of active (ie involved in meetings and able to give time) BBFB
 members there were to maintain such facilities if provided was discussed.
 It was suggested that awareness of the Brigade might be increased
 through current members "spreading the word", provision of membership
 forms at the Wilga Exchange and at Wilga Progress Association
 meeting(s) / Fish and Chip Nights.
- The Rapid Response vehicle is located at Chris Lee Steere's property.
- The spring burns conducted by the Department of Parks and Wildlife (DPAW) late in 2022 were discussed. Concerns aired by members regarding timing and notification (or lack of) provided to landholders living adjacent to burns. Mr Inglis had made contact with DPAW at the time and expressed concerns on behalf of the Brigade and nearby landholders.

8. General Business:

- David Inglis suggested that we discuss intentions for the funds (both at bank and incoming as described in FCO Report). Although flexible with changing needs, it was agreed that in principle funds be used to:
 - Maintain current assets (pumps, slip on fire unit.)

- Remaining funds preserved in order that the Brigade be in a position to contribute in the event that future funding requests are successful (eg for the afore mentioned Wilga firefighting facilities).
- Discussed need for the newly elected FCO (Rob Imrie) to have access to DFES communication radio in his house in order to perform the role. Newly elected DFCO (Clint Westphal) would also need access to a radio. Rob and Clint to make contact with David Fortune (X-Ray Team Communications Officer) in the first instance with this enquiry.
- Rob and Clint will attend Advisory Committee meetings.
- Discussion regarding the firebreak requirements for the former "Affleck" property (purchased by FPC with intention to plant with Pine trees).
 Apparently there is a requirement for a 50m break between the plantings and Wilga town site. Question was asked whether this would be enough and whether the 50m break should extend further. Richard said that the firebreak requirements were currently with Council.
- Richard Walker made the meeting aware that there would be a Local Planning Strategy forum held at the BB Club at 6:00pm on Thu 11 May. Broad acre tree farming in our shire was one of the matters to be discussed. Community members are encouraged to attend.
- Maintenance on the pump at the Wilga "Mill Dam" was discussed. Clint said that he would check this pump and the mobile unit to ensure they were in reliable condition in preparation for the next fire season.
- Discussion regarding communication methods (outside of active firefighting matters) e.g. meeting advice and dissemination of information. Jarred to setup a WhatsApp group for "Benjinup BFB Members", separate from the existing one "Benjinup BFB" which is used by active members for emergency matters.
- Richard brought up the matter of properties that straddle 2 shires and whether there should be consideration for "Joint FCO" in the case of an incident involving these properties. Some complications were identified. Would be more for emergency situations, not burn permits. Matter left with new FCO for consideration and possible discussion at Advisory Committee.
- Richard acknowledged the considerable contribution of David Inglis to the Brigade as FCO over the past 10+ years. Agreed to by all at the meeting. Thank you David.
- Rob Imrie declared the meeting closed at 8:30pm.

Kylie Bleechmore asked about water in the plantations, Dave said he wants one big cell, possibly near Cootamundra, this would give good access from either direction and from a bitumen Road, the plantation people want to use their existing tanks within their plantation, but Dave said no, they need to be more accessible, given the concerns about entering a plantation on fire. Tim Bleechmore asked, shouldn't the water be in place before the trees/pines are planted? The answer is yes as a planning condition but it is not policed. Jodi Wildy asked about how much water they need to provide, Dave said 25,000L as a minimum per plantation but that it does not mention how big a plantation. He said we need to keep pushing them for whatever more they are willing to provide.

Following the Rayner Family's offer to donate \$500 this was very kindly increased to \$1000.00

There was a motion about Life Membership and Honour boards and Natasha Harley will present them in General Business.

FCO Report – Dave Fortune

Dave said there were no fires for the last two years and only minor issues to report, so well done and stay on the ball.

Nothing to report.

Treasurers Report – Ann-Marie Bass

Ann-Marie read out the Financial Report, including the \$1000 donation from the Rayner family, the Honour Plaques, and the cost of purchasing/installing the radio in Kirk's vehicle.

Ann-Marie also mentioned that the bank account is not making any money and suggested that the Term Deposit and Transaction account be changed to a different Bank.

Motion for Ann-Marie Bass to close the Commonwealth Bank Term Deposit and open a new Transaction and or Savings Account and Term Deposit with Unity Bank. Ann-Marie Bass and Dave Fortune to control as any one to operate.

General Business

Dave commented on our brigade's fantastic attendance, he shared his appreciation for all our members' attendance. He has been attending other local brigade's meetings and there is a noticeable lack of attendance in some brigades.

He mentioned it is a shame that a few big farmers/farms have now been sold, and will now become Pine Plantations. He thanked those that attended the Plantation Fire Fighting Course. I mentioned that Donna was still trying to organise training for the newcomers, and she had asked for the Noggerup Hall's contact details as a possible venue (as our hall does not have power).

Dave also mentioned the changes in our community, with the Shine, Wooding, Harley and Rayners all leaving in the last two years. Dave believes it is now even more important to being a close knit community, to keep everyone safe.

Sharon asked why we don't have training days/events, Dave said that we all have our own things on (time poor) but we could call him if we want to know anything, or if you need training he will find out what courses are coming up. It was suggested for another pre fire season get together in early November.

Dave had been told that the block down Wooding Road was having a lot of vehicles/campers going in and out, Peter Blackburn mentioned they had a website that said they had camping sites for rent. Craig mentioned that he went over there in his fire uniform to say there is no fires allowed out of season. Dave said that if the landowner wants to have these types of events, he needs Shire approval, Peter mentioned they had campfires in March (out of season).

When I (Ann-Marie) commented we had new owners of a few blocks around McAlinden, Dave thought that it could have been the new owner of two blocks from Wooding's Property, Lindsay that could be the problem. Upon referring to the Map, we realised that it was not Lindsay at (27) it was in fact Ken Hart at (29). Dave would like to apologise to Lindsay for thinking it was him. We sincerely apologise for this bout of mistaken identity.

Dave mentioned we have applied for MAF funding. Pending approval in July.

If successful Firebreaks will be installed and burning will be scheduled in to burn the T-Junction around Wooding Road, and surrounding the McAlinden Hall next Autumn. Dave wants to burn Chapman Road on both sides. Greg (FPC) has said they are planning to plant a different species of pines around the outside of the plots so they can burn the needle bed for fire management. Let's see if they do?

We welcomed Natasha and Alex Sunderland into Wooding Road (33), previously George and Linda Stads property. Alex mentioned he was previously with DEC and is now working with Worsley, he can also drive the Fire truck.

Ian Faed commented on his work with CALM and being a Forrest Officer for 10 years, he offered insight regarding what to do in and around your property to be fire ready, he said please give me a call if you want any advice?

Sharon T, mentioned that FPC were going to show people how to get out of Chapman Rd in the event of a fire, this has still not been done. Peter mentioned that as there is a couple of turns through the farm to get out, that if you didn't do it regularly that you could forget where to go and as the trees grow it will start to look different. I asked if we could petition to get the gazetted road put though but they said no. Sharon T, mentioned that Sharon Jones (FPC) told them to go through and follow the power lines, Ian said if they go that way, they are likely to get bogged.

Natasha Harley came up to present the Honour boards for recognition of Stephen Harley, Peter Wooding and Laurie Shine. She mentioned they have a 1900's map with the original land holders that we could put up in the hall.

Jack Campbell mentioned that the WhatsApp page was more like a general chit chat than a Fire Alert and could we have another page that is just for emergencies. Ann-Marie said she would organise another page, so we can have one for the Community and one for emergencies.

It was mentioned by Nathan Harley that we should be inviting FPC to the meetings. (I thought I had included them in the email but while preparing these minutes I checked the email, and their names were not there - my apologies).

Nathan Harley mentioned that they are leaving the McAlinden area after many generations due to work and family commitments. Dave thanked them on behalf of the McAlinden Community for their incredible efforts over a long period of time and wished them well for the future.

Peter asked about guidelines for planting/plantations, they keep changing the goal posts.

3. REPORTS

3.1 FCO Report - Marcus Gifford

- Firstly I would like to thank Mick Hester for looking after our brigade. He does a great job in keeping all our members up to date and informed. He organises all the safety gear that anyone requires and keeps our finances on track. Thank you and well done.
- The Nollajup members attended quite a few fires in this reporting period. The main one being the Bridgetown fire last year. Other fires included, Banks Rd, Chillwell's property and some attended a fire near Yornup. Apart from the Bridgetown fire most of the other fires were started by lightning.
- Marcus read out his letter that we sent to all members in October 2022. And the letter went as follows;

Firstly I would like to thank everyone that was involved in the Bridgetown Fire earlier this year. It was a testament to the brigade and the Boyup district fire fighting ability which is often taken for granted by those outside the area.

The main two issues to bring to your attention as an FCO are both obviously fire related and more specifically attending fires in either bush reserves managed by Gov appointed departments and secondly attending fires in plantations (either blue gums or pines).

The legalities of attending such fires and more specifically my role in directing those under my responsibility to attend such fires are unfortunately becoming more complicated.

The consequences for me directing members into a situation where they are not technically qualified or prepared can run into quite serious penalties if the unthinkable happened and someone lost their life or were seriously injured in the process.

With regard to bush and plantation fires the shire is planning on running courses in Oct for members to be "qualified" or accredited to legally attend plantation fires.

It would seem to the best of my knowledge that without the completion of this course and the availability of an accredited vehicle with deluge burn over protection and safety equipment I would not recommend attending a plantation fire yourselves and I won't obviously be directing you to attend for legal and safety reasons.

Attending mopping up operations after burn through are less of an issue but I have reservations personally on this front after witnessing several close calls over the last 30 years from falling trees and limbs. Something we will be discussing going forward.

The purpose of this email is not to convey my opinion on these matters but simply to give you the information you need to understand my "incident response" parameters and to direct you towards the training being provided if you wish as a volunteer to attend to gain plantation accreditation which could well be valuable in the future.

I'm happy to discuss details with any individuals that may have concerns but obviously our foremost goal is to keep everyone safe on the fireground while also avoiding the possible legal implications that can be directed toward those responsible for your movements and wellbeing on the fireground.

- 5.5 There has been plenty of discussion in the past on why aren't slip-ons covered by ESL funding? One of the main reasons mentioned is that the policing on how they are attached to a vehicle is too hard. Another reason is that they can be used for other jobs around the farm that is not fire fighting related. It was mentioned that if they were funded by ESL there would be too many rules and regulations that come with it. We are better off funding our own equipment and that way we keep full control on why and how it is used.

DATES YOU MUST REMEMBER

Prohibited Burning Time

21 November in each year to 28 February the following year, both dates inclusive

Restricted Burning Times (PERMITS REQUIRED)

9 October to **20 November** in each year, both dates inclusive and **1 March** to **30 April** in each year, both dates inclusive. (Note 1. May be varied due to seasonal changes)

Period during which mobile firefighting power unit required when harvesting

15 November to 15 April (The responsibility to supply the unit being that of the landholder)

Automatic harvesting and total movement ban

CHRISTMAS DAY

Burning of Garden Refuse or lighting of open-air Camping or Cooking fires is banned during prohibited times and a permit is required during restricted times.

21 November to 28 February each year, both dates inclusive.

(Permit required 9 October to 20 November and 1 March to 30 April)

Firebreaks must be installed by

30 November

Note -

- 1.Restricted Burning Times and Prohibited Burning Times may be varied due to seasonal changes. Variations will be advertised in a local newspaper and on the Shire's website. It is the responsibility of owners and occupiers of land to ensure they are aware of any variations.
- 2.The Department of Fire and Emergency Services may declare a total fire ban. Such a declaration overrides any other authority. Total fire bans are advertised on the Department's website and broadcast on ABC radio. Information can also be obtained on the Department's Total Fire Ban Information Line 1800 709 355.

RESTRICTED BURNING TIMES

Burning without a permit is prohibited during any restricted burning time. To obtain a permit an application must be made to the relevant Brigade Fire Control Officer (see contact list). Unless permitted by the Chief Bush Fire Officer, permits for hazard reduction of bush will not be issued before 1 April.

A permit holder must -

- (a) no more than 28 days nor less than 4 days prior to commencing the burn, give notice of the intention to burn
 - (i) to the Department of Fire and Emergency Services (on 08 9395 9209);
 - (ii) if the land is to be burned within 3 km of a State forest or timber reserve, to the nearest Department of Biodiversity, Conservation and Attractions Office (Kirup 9731 6232 or Manjimup 9771 7988); and
 - (iii) to the owner or occupier of any adjoining land;
- (b) comply with all conditions on the permit;
- (c) ensure he or she is aware of their obligations and responsibilities under section 18 of the *Bush Fires Act 1954* and regulation 15B of the *Bush Fire Regulations 1954* (as detailed on the reverse of the permit) during any restricted burning times.

PROHIBITED BURNING TIMES

All open-air burning is prohibited during any Prohibited Burning Time.

Note: subterranean clover may be burned during a prohibited burning time but only in accordance with a permit issued by the Chief Bushfire Control Officer.

VEHICLES AND EQUIPMENT

HARVEST AND TOTAL MOVEMENT BANS

The Shire may declare a harvest and total movement ban at any time during a restricted or prohibited burning time. **Christmas Day** in each year is automatically a day on which a harvest and total movement ban is in force.

It is prohibited to use any vehicle with a combustion engine 'off road' during any period for which a harvest and total movement ban has been declared.

This includes any form of fuelled motor device such as, but not limited to -

- aircraft (which, except in an emergency, can only take-off or land on a cleared roadway)
- ride-on lawn mowers
- motorbikes and buggies
- model aeroplanes and cars.

'Off road' means anywhere (including a paddock or area of bush or forest) other than a road or track cleared of all vegetation to a minimum width of 3.0m.

Clover harvesting may continue during a harvest and total movement ban provided -

- (a) any fire hazard in the area being harvested has previously been removed;
- (b) no combustion engine is less than 20m from the firebreak;
- (c) no vehicle enters or leaves a paddock except on a cleared roadway and
- (d) a permit has been issued by the Chief Bushfire Control Officer.

Note: a holder of a clover burning permit must notify his or her base station (see contact list) on the day of the burn, unless the fire is to be lit after 6.00pm.

For current information relating to harvest and total movement bans, phone 9765 1543.

HARVEST MACHINES, HEADERS, MOWERS, SLASHER, STUMP GRINDERS OR SIMILAR

It is prohibited to operate any harvesting machine, header, mower, slasher, stump grinder or similar in any crop during the restricted or prohibited burning times unless –

- (a) a working fire extinguisher is carried on the machine; and
- (b) a working mobile fire fighting unit is -
 - (i) in the paddock being harvested, or adjacent to the entrance of that paddock.
 - (ii) filled at all times with at least 450L of water.
 - (iii) equipped with an efficiently operating pump.
 - (iv) self-propelled or always attached to a suitable towing vehicle.

WELDING APPARATUS AND ANGLE GRINDERS

It is prohibited to operate any kind of **welding apparatus** or **power operated abrasive cutting disk** in the open-air during Restricted or Prohibited Burning Times unless –

- (a) The location where the welding or abrasive cutting taking place is surrounded by a firebreak which is at least 5m wide.
- (b) At least one appropriate fire extinguisher is located and accessible at the place where the welding or cutting operation is carried out.

(b)

STUMP GRINDERS

It is prohibited to operate a stump grinder without written consent (permit) from the Chief Bushfire Control Officer during the restricted and prohibited burning times.

FIREBREAKS

Under section 33 of the *Bush Fires Act*, you are required to carry out the fire prevention work specified below on any land within the Shire that is owned or occupied by you.

The work must be carried out by 30 November, unless approved otherwise, and maintained throughout the summer months until 1 April.

If an owner or occupier fails to comply with these requirements, he or she may be issued with an infringement notice (penalty \$250) or prosecuted, and the Shire may carry out the required work at the cost of the owner or occupier.

If it is impractical for any reason to clear firebreaks, or to take measures in accordance with these requirements, you may apply to the Shire in writing before 11 November, for permission to provide firebreaks in alternative locations, or to take alternative measures to prevent the outbreak or spread of a bush fire. If permission is not granted in writing by the Shire, you must comply with these requirements.

TOWN SITE LAND

On all land located within a town site (except for land zoned Rural and Special Rural as shown in the Shire of Boyup Brook Town Planning Scheme No 2 (**Scheme**)), you must -

- 1. Where the area of land is 2023m² or less, clear the land free of all inflammable matter, except living trees and cultivated plants, shrubs and lawns, that are no greater than 5cm in height.
- 2. Where the area of the land is in excess of 2023m², clear a 3.0m wide bare earth firebreak immediately inside all external boundaries of the land or immediately surrounding all buildings on the land by removing all inflammable matter and vegetation within the 3.0m wide firebreak between the ground and 4m above the ground.

SPECIAL RURAL LAND

On all land zoned Special Rural under the Scheme, you must -

- (a) clear a 3.0m wide bare earth firebreak immediately inside all external boundaries of the land by removing all inflammable matter and vegetation within the 3.0m wide firebreak between the ground and 4m above the ground; and
- (b) clear a 10m wide bare earth firebreak around all buildings and fuel storage areas by removing all inflammable matter and vegetation within the 10m wide firebreak between the ground and 4m above the ground or a 20m building protection zone.

RURAL LAND

- 1. On land zoned Rural under the Scheme, you must either -
 - (a) clear a 3.0m wide bare earth firebreak break immediately around all buildings, homesteads, hay sheds, fuel storage areas, caravans, and mobile accommodation by removing all inflammable matter and vegetation within the 3.0m wide firebreak between the ground and 4m above the ground; and
 - (b) clear a second 3.0m wide bare earth firebreak break around all buildings, homesteads, hay sheds, fuel storage areas, caravans and mobile accommodation located not less than 20m nor more than 100m from the firebreak in paragraph (a) above by removing all inflammable matter and vegetation within the second 3.0m wide firebreak between the ground and 4 metres above the ground.

OR

2. As an alternative to the two-firebreak system described in 1, clear a 10m wide bare earth firebreak immediately around all buildings, homesteads, hay sheds, fuel storage areas, caravans and mobile accommodation by removing all inflammable matter and vegetation within the 10m firebreak between the ground and 4m above the ground.

AND

3. For Rural land (of less than 40ha) adjacent to Special Rural properties, you must –

clear a 3.0m wide bare earth firebreak immediately inside all external boundaries of the land by removing all inflammable matter and vegetation within the 3.0m wide firebreak between the ground and 4m above the ground.

Protective burning

- 1. A permit from the Chief Fire Control Officer is required for any protective burning.
- 2. Subject to the approval of the Chief Fire Control Officer, protective burning around homesteads may be undertaken up to 15 December. (The Chief Fire Control Officer may approve arrangements beyond that date.)
- 3. A permit to undertake a homestead protective burn is also required from the Fire Control Officer for the area in question (see contact list). Subject to the requirements of the Fire Control Officer, a minimum of two mobile firefighting units are generally required for a homestead protective burn between 4.00pm and 6.00pm and one mobile firefighting unit with at least two people is generally required after 6.00pm.

- 4. Unless permission is given otherwise, one adult must be in attendance on the day following any protective burning around a house, hay shed etc.
- 5. Subject to any alternative arrangement permitted by the Chief Fire Control Officer, permits will not be issued for protective burning of bush before 1 April of that year. No fires are to be lit before 1.00pm.
- 6. Prior to carrying out any burning of grassed or stubble areas, a 3m wide bare earth firebreak must be cleared immediately around the area to be burnt. All inflammable matter and vegetation between the ground and 4m above the ground within the 3m firebreak must be cleared.
- 7. (a) Up until 1 April, only the Chief Fire Control Officer can issue a permit allowing the burning of stubble before 4.00pm on any day. If such a permit is issued, 3 mobile firefighting units will be required to be in attendance during the burn.
 - (b) After 1 April, the relevant Fire Control Officer (see contact list) may issue permits for the burning of stubble subject to such conditions as he or she thinks fit.

PLANTATIONS

A plantation is defined as an area exceeding 3ha within a town site, or an area exceeding 20ha within a rural area, of trees planted for commercial purposes. The plantation will cease once the stumps are removed and the area is returned to agricultural production.

Up until the first harvest following the first planting of a plantation, the firebreak requirements for the plantation are those that applied for the fire season in which the plantation was approved by Council under the Scheme.

Further plantings and post-harvest or coppice regrowth or until all stumps are removed will be subject to the then current firebreak requirements.

Subject to the above, on all land on which there is a plantation, you must –

- (a) clear a 15m wide bare earth firebreak immediately inside all external boundaries of the land by removing all inflammable matter and vegetation to a height of 5m.
- (b) ensure all inflammable matter and vegetation greater than 5m above the ground is separated by no less than 10m.
- (c) where a plantation is divided into compartments
 - (i) if the compartments do not exceed 30ha, a 6m wide bare earth firebreak between compartments must be cleared by removing all inflammable matter and vegetation within the 6m firebreak and between the ground and 5m above the ground.
 - (ii) if compartments exceed 30ha, a 10m wide bare earth firebreak between compartments must be cleared by removing all inflammable matter and vegetation within the 10m wide firebreak and between the ground and 5m above the ground.
- (d) clear a 50m wide bare earth firebreak around all buildings and fuel storage areas by removing all inflammable matter and vegetation within the 50m firebreak and between the ground and 5m above the ground.
- (e) where power lines pass through the plantation, clear firebreaks in accordance with Western Power specifications (consult Western Power phone 13 10 87).

BLUE GUM TRASH HEAPS

A permit will be required for burning of tree plantation waste at any time throughout the year. Permits will only be issued by the Chief Bush Fire Control Officer and burning of blue gum trash heaps to be completed by 31st of August annually. All trash heaps are required to be pushed out and levelled by the 30th of October of that year.

CONSTRUCTION OF BUILDINGS

Where a building is under construction on any land between 9 October and 1 May, the land must be cleared of all inflammable matter within a 15m radius of the construction site. The Chief Fire Control Officer and relevant Fire Control Officer will be notified by Shire staff of all building permits granted.

GENERAL INFORMATION

ROADSIDE BURNING

A permit is required to carry out any burning on a roadside at any time of the year. Further requirements may apply e.g. Traffic management.

PROTECTIVE CLOTHING

It is recommended that all members of the public and Fire Fighters wear adequate protective clothing when fighting or attending to fires. Safety boots, long cotton or woollen loose trousers, long-sleeved cotton or woollen shirt, leather gloves, wide-brim cotton hat and safety glasses are the minimum recommended requirements.

INCINERATORS

Any incinerator used to burn rubbish must be properly constructed. An incinerator should be designed and constructed to prevent the escape of sparks or burning material and should be situated 2.0m or more away from any building or fence. An open drum with or without a lid is not an appropriate incinerator.

SPECIAL ORDERS

The requirements specified in this notice are recommended as the minimum standard of Fire Prevention work required to protect not only individual properties, but the district in general. The Shire may issue separate special orders requiring owners or occupiers of specific areas to carry out additional hazard reduction work.

Shire of Boyup Brook FIREBREAK NOTICE 2023 - 2024

FIREBREAKS

Under section 33 of the *Bush Fires Act*, you are required to carry out the fire prevention work specified below on any land within the Shire that is owned or occupied by you.

The work must be carried out by 30 November, unless approved otherwise, and maintained throughout the summer months until 1 April.

If an owner or occupier fails to comply with these requirements, he or she may be issued with an infringement notice (penalty \$250) or prosecuted, and the Shire may carry out the required work at the cost of the owner or occupier.

If it is impractical for any reason to clear firebreaks, or to take measures in accordance with these requirements, you may apply to the Shire in writing before 11 November, for permission to provide firebreaks in alternative locations, or to take alternative measures to prevent the outbreak or spread of a bush fire. If permission is not granted in writing by the Shire, you must comply with these requirements.

TOWN SITE LAND

On all land located within a town site (except for land zoned Rural and Special Rural as shown in the Shire of Boyup Brook Town Planning Scheme No 2 (**Scheme**)), you must -

- 1. Where the area of land is 2023m² or less, clear the land free of all inflammable matter, except living trees and cultivated plants, shrubs and lawns, that are no greater than 5cm in height.
- 2. Where the area of the land is in excess of 2023m², clear a 3.0m wide bare earth firebreak immediately inside all external boundaries of the land or immediately surrounding all buildings on the land by removing all inflammable matter and vegetation within the 3.0m wide firebreak between the ground and 4m above the ground.

SPECIAL RURAL LAND

- (a) clear a 3.0m wide bare earth firebreak immediately inside all external boundaries of the land by removing all inflammable matter and vegetation within the 3.0m wide firebreak between the ground and 4m above the ground; and
- (b) clear a 10m wide bare earth firebreak around all buildings and fuel storage areas by removing all inflammable matter and vegetation within the 10m wide firebreak between the ground and 4m above the ground or a 20m building protection zone.

RURAL LAND

- 1. On land zoned Rural under the Scheme, you must either -
 - (a) clear a 3.0m wide bare earth firebreak break immediately around all buildings, homesteads, hay sheds, fuel storage areas, caravans, and mobile accommodation by

removing all inflammable matter and vegetation within the 3.0m wide firebreak between the ground and 4m above the ground; and

(b) clear a second 3.0m wide bare earth firebreak break around all buildings, homesteads, hay sheds, fuel storage areas, caravans and mobile accommodation located not less than 20m nor more than 100m from the firebreak in paragraph (a) above by removing all inflammable matter and vegetation within the second 3.0m wide firebreak between the ground and 4 metres above the ground.

OR

2. As an alternative to the two-firebreak system described in 1, clear a 10m wide bare earth firebreak immediately around all buildings, homesteads, hay sheds, fuel storage areas, caravans and mobile accommodation by removing all inflammable matter and vegetation within the 10m firebreak between the ground and 4m above the ground.

AND

3. For Rural land (of less than 40ha) adjacent to Special Rural properties, you must –

clear a 3.0m wide bare earth firebreak immediately inside all external boundaries of the land by removing all inflammable matter and vegetation within the 3.0m wide firebreak between the ground and 4m above the ground.

PLANTATIONS

A plantation is defined as an area exceeding 3ha within a town site, or an area exceeding 20ha within a rural area, of trees planted for commercial purposes. The plantation will cease once the stumps are removed and the area is returned to agricultural production.

Up until the first harvest following the first planting of a plantation, the firebreak requirements for the plantation are those that applied for the fire season in which the plantation was approved by Council under the Scheme.

Further plantings and post-harvest or coppice regrowth or until all stumps are removed will be subject to the then current firebreak requirements.

Subject to the above, on all land on which there is a plantation, you must -

- (a) clear a 15m wide bare earth firebreak immediately inside all external boundaries of the land by removing all inflammable matter and vegetation to a height of 5m.
- (b) ensure all inflammable matter and vegetation greater than 5m above the ground is separated by no less than 10m.
- (c) where a plantation is divided into compartments -
 - (i) if the compartments do not exceed 30ha, a 6m wide bare earth firebreak between compartments must be cleared by removing all inflammable matter and vegetation within the 6m firebreak and between the ground and 5m above the ground.
 - (ii) if compartments exceed 30ha, a 10m wide bare earth firebreak between compartments must be cleared by removing all inflammable matter and vegetation within the 10m wide firebreak and between the ground and 5m above the ground.
- (d) clear a 50m wide bare earth firebreak around all buildings and fuel storage areas by removing all inflammable matter and vegetation within the 50m firebreak and between the ground and 5m above the ground.
- (e) where power lines pass through the plantation, clear firebreaks in accordance with Western Power specifications (consult Western Power phone 13 10 87).

SPECIAL ORDERS

The requirements specified in this notice are recommended as the minimum standard of Fire Prevention work required to protect not only individual properties, but the district in general. The Shire may issue separate special orders requiring owners or occupiers of specific areas to carry out additional hazard reduction work.

CONSTRUCTION OF BUILDINGS

Where a building is under construction on any land between 9 October and 1 May, the land must be cleared of all inflammable matter within a 15m radius of the construction site. The Chief Fire Control Officer and relevant Fire Control Officer will be notified by Shire staff of all building permits granted.

DATES YOU MUST REMEMBER

Prohibited Burning Time

21 November in each year to 28 February the following year, both dates inclusive

Restricted Burning Times (PERMITS REQUIRED)

9 October to **20 November** in each year, both dates inclusive and **1 March** to **30 April** in each year, both dates inclusive. (Note 1. May be varied due to seasonal changes)

Period during which mobile firefighting power unit required when harvesting

15 November to 15 April (The responsibility to supply the unit being that of the landholder)

Automatic harvesting and total movement ban

CHRISTMAS DAY

Burning of Garden Refuse or lighting of open-air Camping or Cooking fires is banned during prohibited times and a permit is required during restricted times.

21 November to 28 February each year, both dates inclusive.

(Permit required 9 October to 20 November and 1 March to 30 April)

Firebreaks must be installed by

30 November

Note -

- 1.Restricted Burning Times and Prohibited Burning Times may be varied due to seasonal changes. Variations will be advertised in a local newspaper and on the Shire's website. It is the responsibility of owners and occupiers of land to ensure they are aware of any variations.
- 2. The Department of Fire and Emergency Services may declare a total fire ban. Such a declaration overrides any other authority. Total fire bans are advertised on the Department's website and broadcast on ABC radio. Information can also be obtained on the Department's Total Fire Ban Information Line 1800 709 355.

RESTRICTED BURNING TIMES

Burning without a permit is prohibited during any restricted burning time. To obtain a permit an application must be made to the relevant Brigade Fire Control Officer (see contact list). Unless permitted by the Chief Bush Fire Officer, permits for hazard reduction of bush will not be issued before 1 April.

A permit holder must -

- (a) no more than 28 days nor less than 4 days prior to commencing the burn, give notice of the intention to burn
 - (i) to the Department of Fire and Emergency Services (on 08 9395 9209);

- (ii) if the land is to be burned within 3 km of a State forest or timber reserve, to the nearest Department of Biodiversity, Conservation and Attractions Office (Kirup 9731 6232 or Manjimup 9771 7988); and
- (iii) to the owner or occupier of any adjoining land;
- (b) comply with all conditions on the permit;
- (c) ensure he or she is aware of their obligations and responsibilities under section 18 of the *Bush Fires Act 1954* and regulation 15B of the *Bush Fire Regulations 1954* (as detailed on the reverse of the permit) during any restricted burning times.

PROHIBITED BURNING TIMES

All open-air burning is prohibited during any Prohibited Burning Time.

Note: subterranean clover may be burned during a prohibited burning time but only in accordance with a permit issued by the Chief Bushfire Control Officer.

VEHICLES AND EQUIPMENT

HARVEST AND TOTAL MOVEMENT BANS

The Shire may declare a harvest and total movement ban at any time during a restricted or prohibited burning time. **Christmas Day** in each year is automatically a day on which a harvest and total movement ban is in force.

It is prohibited to use any vehicle with a combustion engine 'off road' during any period for which a harvest and total movement ban has been declared.

This includes any form of fuelled motor device such as, but not limited to -

- aircraft (which, except in an emergency, can only take-off or land on a cleared roadway)
- ride-on lawn mowers
- motorbikes and buggies
- model aeroplanes and cars.

'**Off road**' means anywhere (including a paddock or area of bush or forest) other than a road or track cleared of all vegetation to a minimum width of 3.0m.

Clover harvesting may continue during a harvest and total movement ban provided –

- (a) any fire hazard in the area being harvested has previously been removed;
- (b) no combustion engine is less than 20m from the firebreak;
- (c) no vehicle enters or leaves a paddock except on a cleared roadway and
- (d) a permit has been issued by the Chief Bushfire Control Officer.

Note: a holder of a clover burning permit must notify his or her base station (see contact list) on the day of the burn, unless the fire is to be lit after 6.00pm.

HARVEST MACHINES, HEADERS, MOWERS, SLASHER, STUMP GRINDERS OR SIMILAR

It is prohibited to operate any harvesting machine, header, mower, slasher, stump grinder or similar in any crop during the restricted or prohibited burning times unless –

- (a) a working fire extinguisher is carried on the machine; and
- (b) a working mobile fire fighting unit is
 - (i) in the paddock being harvested, or adjacent to the entrance of that paddock.
 - (ii) filled at all times with at least 450L of water.
 - (iii) equipped with an efficiently operating pump.
 - (iv) self-propelled or always attached to a suitable towing vehicle.

WELDING APPARATUS AND ANGLE GRINDERS

It is prohibited to operate any kind of **welding apparatus** or **power operated abrasive cutting disk** in the open-air during Restricted or Prohibited Burning Times unless –

- (a) The location where the welding or abrasive cutting taking place is surrounded by a firebreak which is at least 5m wide.
- (b) At least one appropriate fire extinguisher is located and accessible at the place where the welding or cutting operation is carried out.

(b)

STUMP GRINDERS

It is prohibited to operate a stump grinder without written consent (permit) from the Chief Bushfire Control Officer during the restricted and prohibited burning times.

Protective burning

- 1. A permit from the Chief Fire Control Officer is required for any protective burning.
- 2. Subject to the approval of the Chief Fire Control Officer, protective burning around homesteads may be undertaken up to 15 December. (The Chief Fire Control Officer may approve arrangements beyond that date.)
- 3. A permit to undertake a homestead protective burn is also required from the Fire Control Officer for the area in question (see contact list). Subject to the requirements of the Fire Control Officer, a minimum of two mobile firefighting units are generally required for a homestead protective burn between 4.00pm and 6.00pm and one mobile firefighting unit with at least two people is generally required after 6.00pm.
- 4. Unless permission is given otherwise, one adult must be in attendance on the day following any protective burning around a house, hay shed etc.
- 5. Subject to any alternative arrangement permitted by the Chief Fire Control Officer, permits will not be issued for protective burning of bush before 1 April of that year. No fires are to be lit before 1.00pm.
- 6. Prior to carrying out any burning of grassed or stubble areas, a 3m wide bare earth firebreak must be cleared immediately around the area to be burnt. All inflammable matter and vegetation between the ground and 4m above the ground within the 3m firebreak must be cleared.

- 7. (a) Up until 1 April, only the Chief Fire Control Officer can issue a permit allowing the burning of stubble before 4.00pm on any day. If such a permit is issued, 3 mobile firefighting units will be required to be in attendance during the burn.
 - (b) After 1 April, the relevant Fire Control Officer (see contact list) may issue permits for the burning of stubble subject to such conditions as he or she thinks fit.

BLUE GUM TRASH HEAPS

A permit will be required for burning of tree plantation waste at any time throughout the year. Permits will only be issued by the Chief Bush Fire Control Officer and burning of blue gum trash heaps to be completed by 31st of August annually. All trash heaps are required to be pushed out and levelled by the 30th of October of that year.

CONSTRUCTION OF BUILDINGS

Where a building is under construction on any land between 9 October and 1 May, the land must be cleared of all inflammable matter within a 15m radius of the construction site. The Chief Fire Control Officer and relevant Fire Control Officer will be notified by Shire staff of all building permits granted.

GENERAL INFORMATION

ROADSIDE BURNING

A permit is required to carry out any burning on a roadside at any time of the year. Further requirements may apply e.g. Traffic management.

PROTECTIVE CLOTHING

It is recommended that all members of the public and Fire Fighters wear adequate protective clothing when fighting or attending to fires. Safety boots, long cotton or woollen loose trousers, long-sleeved cotton or woollen shirt, leather gloves, wide-brim cotton hat and safety glasses are the minimum recommended requirements.

INCINERATORS

Any incinerator used to burn rubbish must be properly constructed. An incinerator should be designed and constructed to prevent the escape of sparks or burning material and should be situated 2.0m or more away from any building or fence. An open drum with or without a lid is not an appropriate incinerator.

Shire of Boyup Brook BFAC DFES Report – May 2023

The DFES Lower South West Region has been active with incidents, with staff assisting Local Shires and DBCA with the management of 6 Level 2 Incidents this fire season. These include the Noggerup, Donnybrook Complex and Yornup fires and most recently the Ashcroft Rd fire in Greenbushes. We would like to recognise the support from all the Shire's emergency services that come out to assist with these incidents, as well as the support and effort from the Shire CEO and staff who have contributed to the Incident Support Group during these significant fires.

Several Total Fire Bans have been put on this fire season across the Region. Some of them have occurred under conditions where some may not have expected a Total Fire Ban to be in place. The new Australian Fire Danger Rating System (AFDRS) looks at the actual fuel loading (age) and type and this is causing a higher Fire Danger Rating to be issued than what has previously been experienced. We are seeking feedback from the Shire and Fire Control Officers on issues that have been identified as part of the new AFDRS. Training and Exercises

Unfortunately, a scheduled helitak demonstration and ground controller refresher was cancelled in December 2022 due to the forecasted weather, and the aircraft were dispatched to Donnybrook later that day. The MAF GP Manager is an appointed Employee to act on the CEO's behalf to ensure MAF expenditure is allocated, recorded, treatment objectives are met and acquitted according to the MAF GP Guidelines set for 2023 – 2024 Round 1.

There has been consultation with the X ray team, Local and State government stake holders to develop the treatment applications for submission.

Identification of assets that have been risk assessed in accordance with the Bush Fire Risk Management Plan and Mitigation Activity Fund Grants Program have also been included as required by the Bushfire Risk Management Branch to meet funding requirements and treatment Objectives .
