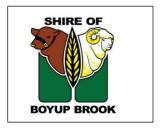

SUMMARY

The Rylington Park Scholarship, founded by the Rylington Park Management Committee Inc., embodies Eric Farley's vision of engaging and nurturing Boyup Brook's youth in agricultural endeavours. Supported by the Shire of Boyup Brook, which continued its commitment after assuming management of Rylington Park farm, the scholarship aims to sustain the agricultural heritage of the community.

BACKGROUND

In the past the scholarship has been approved for any student residing in Boyup Brook who applied and provided a short essay and attended an interview.

REPORT DETAIL

It is proposed to tighten up scholarship criteria which aims to support the Boyup Brook Schools in retaining year 10 students, by providing significant support.

The scholarship is proposed to be awarded to two deserving year 10 students, the proposal to not include year 9 students is to try retain year 10 students. Currently year 9 students who are successful with the scholarship leave Boyup Brook to attend agricultural schools outside of Boyup Brook.

This has resulted in the high school not having any year 10 students this year. It is hoped by providing a substantial scholarship student will remain in a Boyup Brook School until the end of year 10 to be able to apply for the scholarship.

The scholarship not only benefits the selected students but also ensures the ongoing vitality of Boyup Brook schools.

- The first Scholarship valued at up to \$5,000, covers the tuition fees for the recipient's Years 11 and 12 education at the Agricultural school of their choice.
- The second Scholarship valued at up to \$2,500, covers portion of the tuition fees for the recipient's Years 11 and 12 education at the Agricultural school of their choice

SUMMARY

The monthly report is to provide Council with an update on the operations at the Rylington Park Farm.

BACKGROUND

The Rylington Park Institute for Agricultural Training and Research, known as Rylington Park, is a key agricultural asset located 27km from Boyup Brook, in Mayanup.

This 650-hectare property was donated to the Shire of Boyup Brook in 1985 by Mr. Eric Farleigh for agricultural research and training, aimed at the betterment of the Boyup Brook community. Managed by the Shire, the property runs various agricultural programs, including shearing schools and fertiliser and seed trials.

It also offers scholarships to youth in agriculture and has a strategic relationship with Edith Cowan University for research and education, with the intent to share findings with the local farming community. Rylington Park is committed to supporting the agricultural industry and the regional community through its various initiatives.

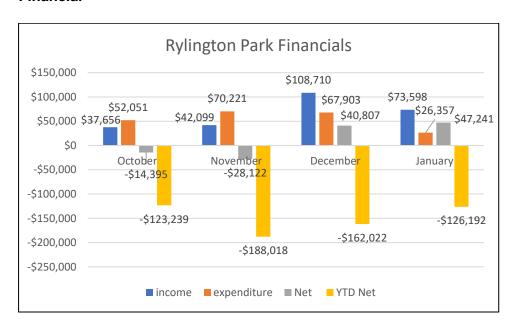

SUMMARY

The Committee is requested to consider the annual cropping report to enable the farm Manager to commence purchasing and preparations.

BACKGROUND

The purpose of an annual cropping management system for farmers is multifaceted, aiming to optimise agricultural production, ensure sustainability, and maximise economic returns.

The key objectives:

- Maximising Crop Yields: by planning the types of crops to grow each year and determining their planting and harvest schedules, farmers can make the most of their land and resources. This involves selecting crop varieties that are well-suited to the local climate and soil conditions, as well as timing plantings to take advantage of the optimal growing condition.
- Improving Soil Health: Annual cropping management involves rotating crops to prevent soil depletion, reduce pest and disease buildup, and improve soil structure and fertility.
