Charter of Rylington Park Institute for Agricultural Training and Research



This Charter confirms that the Rylington Park farming property, home of Rylington Park Institute for Agricultural Training and Research, will be held in trust by the Boyup Brook Shire to benefit the Boyup Brook community and for the use of agricultural training and research.

Rylington Park was gifted to the Shire of Boyup Brook by Mr Eric Farleigh in 1985 to be used for agricultural training and research as this will benefit the town and district as a whole. A quote from Mr Farleigh's last will and testament dated 8th June 1988 states:

"Without creating any specific trust it is my wish that my farming property be retained by the Shire of Boyup Brook for the benefit of persons within the Shire and for research purposes and that my farming records and other records are kept with my farming property."

Eric Farleigh 8th June 1988

The transfer of the farm was officially announced on 2nd November 1985 in order to coincide with a visit to Boyup Brook by the Governor of Western Australia.

After gifting the farm to the Shire, Mr Farleigh continued to live on Rylington Park until his death on 11th November 1988.

OBJECTIVES

The objectives for Rylington Park Institute for Agricultural Training and Research are to:

- Demonstrate good governance and leadership by behaving with integrity and being open and accountable.
- Be recognised as a leader in technology use, training, and sustainable practices.
- Develop, trial and demonstrate the latest agricultural practices and technologies.
- Develop and demonstrate sustainable farming practices to sustainably manage the farm for future generations.
- Deliver industry relevant training.
- Deliver enhanced skills development for the farming community.

ACTIVITIES

To achieve these objectives, the Rylington Park Institute for Agricultural Training and Research will undertake specific activities in the following areas:

- Develop and maintain active partnerships with educational, training and research institutions to conduct training and research in all aspects of agriculture and facilitate these learnings to be shared with the Boyup Brook community.
- Collaborate with local farmers, businesses and organisations to participate in trials and demonstrations.
- Host industry workshops and training days.
- Host rehabilitation and regeneration trials for disused gravel pits and other degraded land.
- Encourage the use of the Rylington Park facilities for broad community participation and involvement.
- Invest in maintenance and ongoing improvements to the farm and facilities to ensure continued use and relevance for future generations.
- Engage the community in annual field days.
- Provide support to the youth of Boyup Brook with agricultural scholarships.
- Contribute to community based projects and activities.
- Provide regular updates on Rylington Park activities to the Boyup Brook community.

(the 'Parties')

Background

- A. Edith Cowan University is a public university established pursuant to the *Edith Cowan University Act 1984* and wishes to develop its relationships with respected education and training institutions.
- B. The Shire of Boyup Brook is a local government authority. The Shire owns and operates the Rylington Park Institute for Agricultural Training and Research (Rylington Park) (1437 Boyup Brook-Cranbrook Rd, Scotts Brook WA 6244) and through the institute is engaged in agricultural trials and research, industry-based training, and events such as field days and expositions.
- C. The Parties recognise that collaborative efforts will be of mutual benefit and may contribute to an enduring institutional linkage for research and education, co-operation and mutual assistance.
- D. The Parties are interested in exploring the possibility of establishing a cooperative relationship, including the carrying out of projects or activities relevant to their respective capabilities.

Scope of Collaboration

The Parties agree to continue discussions as opportunities arise to ascertain how co-operative activities could be implemented in the future. These activities could include:

1. Utilising Rylington Park for agriculture and regional development related research and allied education programs;
2. Conducting demonstrations and workshops for new and emerging technology;
3. Exploring new or novel approaches to sustainable agricultural systems;
4. Exploring new or novel approaches to marketing and supply chain completion;
5. Sharing and disseminating information and research outcomes with farming and regional communities;
6. Engage in discussions and activities regarding the development of programs and services in specific areas of mutual interest in the areas of agricultural sector education and research development and, regional development;
7. Endeavour to identify potential projects of interest to the parties to this agreement;
8. Engage in discussions and activities regarding the development of proposals for collaborative projects and allied research and education endeavours between the parties.

This document is a statement of the Parties' intentions at the date of this Memorandum of Understanding and is not intended to create a contractual relationship or be legally binding.

This Memorandum of Understanding will commence on the date shown below and operate for a 20 year term comprised of an initial 10 years and renewable for a further 10 years.

Should specific joint activities arise as a result of further discussions, details will be set forth in an Agreement, to be signed at the appropriate time by the authorised representatives of the Parties.

Be it so understood and agreed on this 29th day of October 2021.



ECU and Rylington Park Institute for Agricultural Training and Research Report

To October 2025

Projects and research activities between ECU and Rylington Park Institute for Agricultural Training and Research

Research Workshop Rylington Park 25 November 2021: The partnership was supported by an initial Workshop to identify areas of research expertise and common interest in areas of concern by the Boyup Brook and surrounding region community. These areas of interest were documented and sent to the Rylington Committee with an offer to develop the research areas further. Eleven academics from the disciplines of Science and, Business & Law, ECU travelled from Joondalup to Rylington Park to participate in the workshop.

Equipment funded by ECU 2021: Small grant funding to set up a Wide Area network – stretching approx. 4-5 km across Rylington Park was provided through an ECU funding scheme. The main equipment was set up in the Training Room, designated for ECU's usage, making training and research capability at the basic level available. The equipment allows demonstration metrics in a Dashboard on a 32" Screen to visitors and people being trained in LoRa techniques. It can show daily read-outs such as Air Temp, Soil moisture measurements, Fox numbers (nightly motion counts), as well as camera imagery of wheat / crop areas and giving Rylington a set of data records, including providing a link between ECU and Shire of Boyup Brook with data that can be used from Joondalup ECU as well as Bunbury campus ECU. The system can be built on over time with further funding – allowing other projects and integration with existing Shire projects as well as showing an ECU data presence at Rylington Park. There was some onsite work to install the tower structures and to dig a short trench for a required cable run provided on an in-kind basis.

Pathways to University Program for Regional Students – Research Project: A meeting with the Director of the National Centre for Student Equity and Success (NCSES) Prof Shamit Saggars in April 2023 was undertaken to discuss the proposal for the research grant. The previous Director of Trial Program Dr Lien Pham met on Wednesday 20 December 2023 with ECU and Rylington Park Committee members. An application for grant funding for trials and evaluation of programs that address student equity was submitted in the Small Scale Trials program in May 2024. ECU, Rylington Park Agricultural Research and Training Committee, Boyup Brook Shire and High School agreed to be involved in a 12 month trial program and evaluation for the intervention of regional education offered at Rylington Park to support retention of students in the region to study agriculture and business and providing pathways to university studies. The **National Centre for Student Equity in Higher Education (NCSEHE)** is an evidence-based research and public policy centre funded by the Australian Government Department of Education and based at Curtin University. The project team were advised the project was unsuccessful on 5 August 2024. **Project Team** Kerry Brown, Claire Lambert, Ruth Sibson, Neda Kiani Mavi, (SBL ECU); Melissa Reimers (Principal Boyup Brook High School).

Objective: To develop and better understand several integrated systems of carbon credits, restoration of degraded areas, and Shade, Shelter, Forage planting and livestock management.

A Greening Australia representative visited Rylington Park on 13 September 2024 to investigate possible sites on the farm for undertaking the project. A presentation was made to the Rylington Park Committee

explaining the project and a detailed project brief was developed and presented. The committee was not able to support the project in its present form. Greening Australia withdrew support for the project.

The project represents a large investment of time and research into building an innovative integrated three-pronged approach to support and develop degraded land; build a more resilient landscape; and reap benefits from carbon farming that support more productive farming landscapes. For example See attachment 4

AWI has modified this project to a smaller scope research project under the concept of a *Shade, Shelter Fodder* project as part of their research portfolio of funding requests to third party funders, the Woolmark + program but this project has not been chosen to be funded by external partners to date.

Industrial Hemp Project

A meeting at Rylington Park Farm on 21 November 2023 inspected a possible site for a Dryland Hemp Trial. DPIRD Manjimup were also present at the Rylington Park Farm inspection and meeting.

A meeting was held with John Muir and Don Telfer on Thursday 14 December 2023 to discuss possible funding sources for the trial. A trial site has been chosen at Rylington Park, and the project is expected to be progressed for the 2025 winter growing season.

Hemp Trial showcase at Manjimup attendance: Kerry Brown (ECU) and Cr Darren King, February 2024. This trial was with multi-varietal hemp varieties and with irrigated crops. The proposed trial at Rylington Park is a dryland crop planted to produce a winter crop to test whether a dryland winter hemp crop is able to be introduced into SW Western Australia. Downstream processing facilities and supply chain and logistics for industrial hemp especially in the construction industry is project of interest to AgFutures. The possibility of a project in this area was discussed with AgriFutures Australia Emerging Industries Program Senior Manager, Dr Olivia Reynolds at the Manjimup Field Day hemp trial showcase and she was supportive of the project idea. AgriFutures will be approached for further discussions following the hemp trial implementation. The next stage is to secure licences for hemp production and to seek funding for the trial.

Sheep Count

Dr Dave Blake undertook a sheep count at Rylington Park using drone technology. The WA Audit Office has responsibility for auditing the number of sheep and last year a drone count was instigated as a trial to understand whether the count was accurate and the audit requirements could be met with a drone count.

Safety signage for safe road crossing of sheep

Dr David Cook, ECU was requested to undertake a small project to develop solar powered safety signage for safer road crossing for sheep. This project requires further development and approval from Rylington Park Committee as it was initiated from the previous farm managers and no further action has been taken. Funding for the project would need to be sought or supplied.

Rylington Park Field Day 23 September 2022. ECU research contribution with a range of guest speakers at the Field Day: Prof Ken Nosaka, farmer health; Prof Pierre Horwitz, resilient landscapes; Assoc Prof Ferry Jie & Assoc Prof Flavio Macau, supply chain and logistics; Dr Anna Hopkins, regenerative agriculture; Dr Dave Blake, soil science and drones – see topics below (Appendix 1).

Rylington Park Field Day 14 September 2023 ECU's contribution to Rylington Park Field Day included ECU stall at the Field Day. A formal presentation by Dr David Cook, ECU outlined research projects in sensors and sensor capability and updated about drone sheep count and soil biomass projects – See appendix 2.

Rylington Park Field Day September 2024. ECU provided a booth at the event. Greening Australia was invited by ECU to support a booth as part of the ECU, Rylington Park and Greening Australia research collaboration.

The Boyup Brook High School was in attendance as a start to their greater engagement with Rylington Park and ECU following the ACES grant application.

Rylington Park Field Day 12 September 2025. The health campus at ECU was to support the Field Day with a booth but staff were not able to attend due to illness.

NRM Event co-hosted with ECU 23 October 2024 *Preparing for Drought Workshop* ECU presenters Dr Mary Hansen and Prof Kerry Brown. Project was funding paid to Rylington Park Committee by the SW NRM to fund the workshop See Appendix 3 for details.

Storm in a Teacup event 2025 ECU supported with attendance and an ECU stall focussing on Health staffed by the SW Health Campus.

Proposed **Workshop** and research collaboration on **Farmer well being and risk management** Associate Professor Marcus Cattani for 2026.

DRONES TO HELP WITH LIVESTOCK

AIDAN SMITH

Drones could soon replace the need for farmers to mount quad bikes to check on stock after new camera technology research was able to identify individual sheep in clusters from hundreds of feet up. Farmers in the South West were introduced to the research by Edith Cowan University lecturer Dr David Cook at the Rylington Park annual field day at Boyup Brook in September.

Mr Cook, who was recently awarded Achiever of the Year, and co-winner of Transformative Solution of the Year at the WA

Information Technology and Telecommunications Awards 2023 in August, said drone technology could soon pay dividends for farmers who were busy and needed detailed information about their flocks in real time.

He said, working in conjunction with Dr David Blake, also of ECU, who owns a few high functioning drones — and having secured some funding from the Shire of Boyup Brook — they were able to flight test the drones, worth from \$30,000-\$100,000, at Rylington Park.

“You can go down to the shops and buy a recreational drone for

\$1000 and fly through the air and hopefully it doesn’t crash,” Mr Cook said. “The kinds of drones we are talking about are at a different level, we are talking about those that fly a lot higher into controlled air spaces, and are able to fly in the wind, beyond the visual line of sight at up to 70 kilometres per hour.

“They can also take a payload of up to 25kg, which will lift some large heavy camera equipment for very unique photographing, or otherwise it could be used for weed spraying or other things like that.”

With the drones they focused

a part of their research on counting sheep in paddocks.

“One of the things we can do is fly a drone at 120m — we could fly lower but sheep don’t like the sound of drones and it makes them move,” he said.

“If you want to count them and do it accurately you don’t want the sheep scattering off.

“We can take great photographic images at that height.”

The images were able to pick up sheep in clusters, or against fences and other objects and identify them individually.

He said this was something that could be a challenge for the

naked eye in the field, and which would give sheep producers a better understanding of what was happening with their flocks at real time.

“This is the type of stuff that is emerging — the future is coming and I think drones will play a big part in how we control the movement of sheep,” Mr Cook said.

The research included using fixed wing drones that could be used to cover cropping areas at much faster speeds and greater heights to pick out chemical application densities and issues that may be occurring with the crops.
