7.1 Chief Bush Fire Control Officer 2018/2019 Report

David Inglis advised the Committee that it has been a quiet season with only 3 fire incidents to report.

- On 27th November a fire (1/2 acre) started out at Doug Corker's property, 3 units turned up.
- On 14th December a fire was deliberately lit my a young adult, it took 1 hour to contain the fire. The Police got involved and charged the offender.
- In January 2019 a fire (25 acres) started out at Ian Parker's property, 25 units turned up and a bulldozer was used which was at the next property.

David advised the Committee that he has been in this position for 4 years and it is time to step down. David said he has received a broad range of experience since he has been in the position and would like to thank the Brigade's for the help and support they have provided him with.

David mentioned that we need to control what we do within our Shire and keep control of our destination.

David thanked Tristan Mead for being Deputy for the last 4 years, also thanked Brad Fairbrass for being the Fire Weather Officer and thanked Ben Creek and David Fortune.

9.2 MOU - Mutual Support in Planning and Responding to Bushfires within or Near Plantation Estates and Other Bushfire as Required (please refer to attachment)

The purpose of this MOU is to establish emergency response capability arrangements for bushfire within or near plantation estates and for bushfires where plantation resources maybe used to support the local bushfire fighting response. It addresses overarching arrangements for bushfire response between plantation Managers, State fire agencies and bush fire brigades.

Local governments play a critical role in bushfire response and capability through their turn out of the bush fire brigades particularly in regional areas. The Shire Boyup Brook has been identified as having a plantation estate/s within its boundaries. As such, the participation of the Shire of Boyup Brook in this MOU would be beneficial for and will strengthen the local bushfire fighting response.

Brigade representatives were given the opportunity to review the documentation and the Memorandum of Understanding so that a so that they could discuss the proposal and formulate a recommendation to Council on this matter.
