Successful Grant Funding

Over the past month, the Shire has successfully been awarded grant funding for the following projects:

- \$19,430 through the Department of Water and Environmental Regulation's Community Water Supply Partnerships program, which will enable us to purchase and install a Solar-powered Standpipe for the community to access water for agricultural and livestock purposes during periods of low rainfall when required. This will be located at the southern end of Sandakan Park near Cowley Street.
- \$50,000 from the WA Football Commission, through its WA Football Facilities Fund, which will go towards the redevelopment of the Sports & Recreation precinct, and specifically providing accessible and all-inclusive changerooms. We're also working on other grant applications to contribute to this important community priority so watch this space!

Important Information Regarding Rates Payment Options





Did you pay your first rates instalment or pay in full by the 16th September 2024? When a payment is made after the due date, the instalment option is automatically made unavailable and no reminders or statements are sent. If you missed the payment date, please contact the Rates Officer to discuss available options.

The Shire of Boyup Brook offers 5 different ways to pay your rates. These are:



BPay - Biller Code 151662, the reference number can be found on the bottom left of each notice. Each property has a different reference number so please pay these individually. It is the ratepayers responsibility to allocate payments to the correct property assessment.







Cheque - Please make cheques payable to Shire of Boyup Brook and include the payment slip at the bottom of your Rates Notice. Mail to Shire of Boyup Brook, PO Box 2 Boyup Brook 6244. If you would like a receipt, please request one as receipts are not automatically mailed out.



Phone - Payment can be made by credit card or debit card. Phone the Shire of Boyup Brook on 9765 1200. Please quote your Assessment number or numbers if you are paying for more than one property.



Direct Bank Deposit - Pay directly to the Shire from your bank account. Please make sure to add your Assessment number in the description. If you are paying for more than one property, please email the Shire and let us know what the Assessment numbers are and how much you are paying for each property. Please phone the Shire for details.

If you are experiencing financial difficulties in paying your rates, please contact the Shire to discuss payment arrangements.

A Firebreak and Fire Hazard Notice - Frequently Asked Questions

- Q What is the Shire of Boyup Brook Firebreak and Fire Hazard Notice?
- A The Shire of Boyup Brook Firebreak and Fire Hazard Notice is a legal document under section 33 of the Bush Fires Act 1954 that instructs landowners/occupiers of the actions they must take to prepare their properties for the upcoming fire season. Landowners/occupiers who fail to comply with conditions contained in the Firebreak and Fire Hazard Notice by the date of inspection may be issued with a penalty of up to \$5,000.00 under the Act.
- Q What happens if I never received a copy of the Notice or have misplaced it? What can I do? A There are a few options available to you.
 - Contact the Shire of Boyup Brook during office hours for another copy to be posted out to you.
 - Copies are available to be picked up from the Boyup Brook Shire Office.
 - The Firebreak and Fire Hazard Notice can be found on the Shire website www.boyupbrook.wa.gov.au

Please note if you did not receive the Notice in the mail, you are still bound by the requirements of the Notice.

- Q I live in town, do I need to comply with the Fire Break and Fire Hazard Notice?
- A Yes. All residents/landowners/occupiers of land within the Shire of Boyup Brook, including those with land within town sites, are required and have the shared responsibility to ensure that they comply with the Firebreak and Fire Hazard Notice.
- Q How will reducing fuel loads on my property make a difference if a bushfire comes through?
- A Reducing the fuel loads around your home means that embers from a bushfire will have less chance to catch fire when they hit the ground. This will also reduce the damage caused by the fire and slow the rate of spread of the fire. The better you prepare your property the higher the chance it will survive a bushfire, even if you are not there.
- Q Why does a fire break need to be bare earthed and need to be 3 metres wide with 4 metres vertical clearance?
- A Fire breaks, when established, need to be a bare earth mineral break which assist in preventing the spread of fire into neighbouring paddocks and exposes the terrain to drivers of firefighting appliances. If erosion or other land use issues prevent a bare earth fire break being established where required, you will need to apply for a variation to that requirement (you must apply no later than 1st October).
 - Breaks are required to be 3 metres wide with 4 metres vertical clearance to allow clear access to firefighting appliances. Current firefighting vehicles are already 2.5 metres wide and 3.5 metres in height, which provides enough room for vehicles to negotiate and transverse firebreaks. Vertical clearance is required to limit damage to firefighting appliance and eliminate crews working on the crew deck getting injured from over hanging tree branches.
- Q Can I just use a chemical herbicide spray to kill the grass to create a firebreak?
- A No, all firebreaks are to be bare mineral earth. Whilst spraying herbicides will kill off weeds/plants/grasses and stop growth, the dead material also creates a flammable fuel source if the weed/plant/grass has not degraded down to bare earth.
