Foot and Mouth Disease (FMD)

Foot-and-mouth disease (FMD) is a highly contagious animal disease that affects cattle, sheep, goats and pigs.

The risk to Australia remains low in the absence of close contact between animals or the importation of infected products or contaminated clothing and footwear. But FMD can spread through close contact between animals and be carried on animal products or by the wind.

Anyone keeping or working with cattle, sheep, goats or pigs should be aware of the signs of FMD: blisters in and around the mouth area, drooling and limping animals. If livestock show any unusual signs consistent with FMD, this must be reported urgently to a local veterinarian or the Emergency Animal Disease Watch Hotline on 1800 675 888. The best chance of being able to contain and eradicate an FMD incursion will rely on early detection and reporting.

It is important that you have and follow an up-to-date farm biosecurity plan when welcoming people to your property. Everyone has a role to play in protecting not only our livestock industries, but also the welfare of our animals.

Did you know?

- Having your cat microchipped, registered and sterilised by the age of six months is mandatory unless you are a registered breeder of cats. Failing to do so can incur fines.
- With the passing of the Dog Amendment (Stop Puppy Farming) Bill 2021, unless exempt, all dog owners will be required to sterilise their dog by the time they reach two years of age.
- When your cat or dog is sterilised, registration fees are 50% cheaper!
